INSPECTION OF NEWTOWNBUTLER PRIMARY SCHOOL, ENNISKILLEN (201-1879) - 28 MAY 2012

INSPECTION LETTER

The Education and Training Inspectorate (ETI) notified Newtownbutler Primary School of its forthcoming inspection scheduled for the week commencing 28 May 2012. Prior to the inspection, the school informed ETI that none of the teachers would be co-operating with the Inspectors on advice from their trade union. The teachers are involved in action short of strike in relation to pay, pensions and terms and conditions of employment and reductions in the education budget. The action is not connected with the inspection process itself. Where the inspection is not carried out in full, parents and stakeholders have no complete external evaluation of the quality of education being provided by the school.

Owing to the non co-operation of the teachers, the Inspectors were not able to assess the quality of learning for the children and to identify areas where provision is strong or where improvements are needed. They were not able to:

- observe learning and teaching in any of the classes;
- observe directly the children at work or to talk to them about their work;
- evaluate the quality of the pastoral care provision and safeguarding arrangements for the children;
- evaluate the quality of the provision made for the children with special educational needs;
- scrutinise the school's internal assessment data on the attainment and progress of the children;
- discuss the development of the key curricular areas under focus with the co-ordinators;
- discuss the leadership and management of the school with the Principal; and
- elicit the views of the parents through the parental questionnaire normally distributed by the school.

The Reporting Inspector met with the Chair of the Board of Governors (governors) to discuss various aspects of the life and work of the school. He reported that the school enrolment is increasing and the budget currently facilitates the appointment of an additional teacher to cater for the children with special educational needs. The school reports that it is engaged in productive shared education programmes with two neighbouring schools. It was reported that the governors are kept well informed about all aspects of the school provision and are fully supportive of the Principal and her staff.

A verbal assurance was given that the school is compliant with the Department of Education's (DE) safeguarding policies and procedures for the protection of children.

CONCLUSION

The school's inspection is incomplete. The ETI will return as soon as possible and with little or no additional notice to complete the inspection and to issue a published report. This will include undertaking all the aspects of the inspection which were not possible during this inspection.
